


THE FOLLOWING REVISIONS, ADDITIONS AND/OR CLARIFICATIONS SHALL FORM A PART OF THE PROPOSAL DOCUMENTS AND EACH OFFEROR SHALL INDICATE WITH THEIR PROPOSAL THE RECEIPT OF THIS NUMBERED AMENDMENT. REVISIONS, ADDITIONS, AND/OR CLARIFICATIONS ARE AS FOLLOWS:

- 1.) Carpet face weight shall be revised to **18 oz. Nylon** (no pattern), please revise any indication in bid documents that refer to the 28 oz. carpet tile. Cove base remains the same.
- 2.) The spaces in diagrams #1, #2, #6, #8, #10, #11 currently have tile; spaces in diagrams #3, #4, #5, #9, #12, #13, #14, #15, #16#17 have carpet with threshold strips. Alternate space in diagrams #18 is cement floor and space in diagram #7 is a combination of cement/tile floor.
- 3.) On diagram #1, the inlet that is currently “gray” shall be figured into project. Space is 5’3 x 5’5.


DIAGRAM #1: ADMIN HALLWAY



- 4.) On diagram #6, in the Lieutenant's Office, there are two doors that bottoms need to be cut down 2-3 inches for carpet installation purposes.




- 5.) On diagram #7, the Conference Room (red highlight) in the upper left hand corner has been eliminated from project. Please do not figure this space in your cost of project.



- 6.) On diagram #8, the end of hallway, shall be figured as a 9 x 10 space (yellow highlight) and a 4 x 9 space (teal highlight). Also the East side of the hallway's measurement shall be revised to 88' (not 8').


DIAGRAM #8: INVESTIGATIONS/SERGEANTS
