2. Revenue And Expenditure Approval To Purchase Smoke Alarms

Yogash Kumar donated \$2,000.00 to the Gallup Fire Department to purchase smoke alarms. As part of our Community Risk Reduction Programs the Gallup Fire Department offers smoke alarms and combination smoke/carbon monoxide alarms to homes in our community free of charge including installation. These funds will be used to purchase smoke alarms and smoke/carbon monoxide alarms to continue this program in our community. If approved the Gallup Fire Department will move forward with purchasing of the alarms.

3. Revenue And Expenditure Of \$2,965.00 For FY' 24 Trauma System Development Grant

The Gallup Fire Department was awarded \$2,965.00 from the New Mexico EMS Bureau Trauma Fund to purchase pediatric restraining systems for our rescue units. Our rescues have a built in car seats but they are designed for specific age and weight ranges and are not designed for a Firefighter / EMT to provide patient care in. These new pediatric restraint systems are designed to be quickly installed on our gurneys and will allow us to safely transport pediatric patients of multiple sizes and ages while also allowing our Firefighter / EMT's to provide medical care to the child. The Gallup Fire Department worked with several vendors on a trial basis to find the pediatric restraint systems that would work best for us and our community. If approved these pediatric restraining devices will be purchased by the Fire Department and this grant award will reimburse our department.

The 206 EMS Fund will cover the initial purchase of the restraining devices and the grant will refund up to \$2,965.00. The difference between the quote and the grant will be covered by current approved 206 EMS Funds.

Fiscal Impact: Quote for the pediatric restraining devices was \$3,148.40.

The grant award is \$2,965.00. The restraining devices will be

purchased from the 206 EMS Fund and the grant will

reimburse up to the \$2,965.00. The remaining \$183.40 will be

from the 206 Fund.

2. Request \$20,764.26 In Funding From General Fund Reserves And A Budget Adjustment For OFPL Expenditures.

The main library continues to experience vandalism after hours, which includes broken windows, fires, tagging, and destruction of city property. The outdoor locker system purchased for picking up library materials at the cost of \$15,279.00 and installed in 2022, was vandalized and is no longer functioning. The computer screen that facilitates access, must be replaced at a cost of \$4401.00. To prevent further vandalism we have asked facilities to help with the design and installation of a wrought iron fence that can be locked after hours and accessible with a code. The cost of building and installing the fence is \$16,363.26.

Fiscal Impact: \$20,764.26 in funding from general fund reserves and a

budget adjustment for OFPL expenditures.
