



#### **Property Tax**

Property taxes are levied to fund the costs of state and local governmental operations, infrastructure and debt service. Within the City of Gallup, taxpayers are levied to support:

- State Debt Service
- Gallup-McKinley County Schools
- City of Gallup
- McKinley County
- Rehoboth McKinley Christian Hospital
- University of New Mexico-Gallup

#### **Property Tax**

#### **Assessed Valuation**

Property is taxed at 33–1/3% of the assessed value. The levies shown above represent the tax rate paid per thousand dollars of taxable value.

Example for a \$150,000 home:

Taxable Value	\$50,000 (1/3 of the full value)
x levy	31.658
Total Property Tax	\$1,582.90

The State of New Mexico does not have a sales tax. Instead, the state has a gross receipts tax, which is imposed on persons engaged in business in New Mexico. In almost every case, the person engaged in business passes the tax to the consumer either separately stated or as part of the selling price. Only in its effect on the buyer does the gross receipts tax resemble a sales tax. The gross receipts tax rate varies throughout the state from 5.125% to 8.8675% depending on the location of the business.\*\*

As of August 1, 2012, the gross receipts tax rate within the City of Gallup is 8.0625%.


#### Components of the Gross Receipts Tax Rate

The gross receipts tax rate is comprised of several components:

Local Option (Gallup)	1.8125%	1.0050/	stat	tewide.
County Option (McKinley)  Total GRT	1.125% <b>8.0625</b> %	1.625% <b>6.750%</b>		

Taxes are collected and sent to Santa Fe, where the revenues are divided and shares distributed back to the state and local entities.


# Gross Receipts Tax Revenue Distributed to Local Governments






City of Gallup rate vs. other New Mexico municipalities Local option: 1.8125%
